

# AÉROPORTS DE MONTRÉAL

## PUBLIC NOTICE FOR REGULAR SERVICES TAXI PERMIT OWNERS

**Montréal, July 31<sup>st</sup> 2010** - Aéroports de Montréal («ADM») wishes to grant three hundred and ten (310) Airport Taxi Permits for the Montréal Pierre Elliott Trudeau International Airport (the «Airport») and invites all regular services taxi permit owners to submit their candidacy, the whole in accordance with the following terms and conditions.

### **Conditions of Eligibility (collectively the « Conditions ») :**

Only candidates meeting the following conditions will be eligible:

1. Be the holder of a valid regular services taxi transportation permit issued by “Commission des Transports du Québec” and assigned for the territory of the Island of Montréal and more particularly for Area A.5 : East of Montreal; Area A.11 : Montreal; or Area A.12 : West of Montreal.
2. Be the holder of a valid identification sticker from the “Bureau du taxi et du remorquage de Montréal”.
3. To satisfy the conditions from the “General” and “Particular Conditions” governing the eligibility of the candidates, issued with the application form which is available as of August 2<sup>nd</sup> 2010 through August 13<sup>th</sup> 2010, at the “**Bureau du taxi et du remorquage de Montréal**” (4949 Molson street, Montreal) from Monday to Thursday, (8:30 to 4:00PM) and Friday, (9:00 to 4:00PM) .
4. To submit the duly completed application form, at the “Bureau du taxi et du remorquage de Montréal” (4949 Molson street, Montreal) on the above mentioned opening hours, **no later than August 13<sup>th</sup> 2010**. Registration form not duly completed or received after August 13<sup>th</sup> 2010 at 4 PM will automatically be rejected, whatsoever the reason.

The candidate can submit only one candidacy in order to obtain an Airport Taxi Permit (maximum of 1 permit per owner of regular services taxi permit), under penalty of having all his applications forms, related to this draw, cancelled.

5. Applicant cannot have any outstanding account with ADM;

**Registration Costs:**

Each candidate who wish to offer his candidacy following this public notice, must pay, with his inscription's deposition, registration fees of ten dollars (\$ 10.00), by cash, bank card or cheque at the order of "Bureau du taxi et du remorquage de Montréal".

**Selection:**

On August 25<sup>th</sup> 2010, under the supervision of an accounting firm, the "Bureau du taxi et du remorquage de Montreal" will proceed with a draw for the issuance of the three hundred and ten (310) permits.

The permit will be issued according to the following ratios:

- A-05: 41 permits
- A-11: 217 permits
- A-12: 52 permits

**The results of the draw will be posted on August 27<sup>th</sup> 2010 on ADM website (admtl.com) and at the "Bureau du taxi et du remorquage de Montréal".**

**Reservations:**

Notwithstanding any provision to the contrary, ADM reserves the right to:

- Disqualify a candidate in the event that its application form does not contain the necessary information to permit a thorough analysis;
- Disqualify a candidate in the event that the candidate do not qualify under the "Particular" and "General Conditions" which comes with the application form;
- Disqualify a candidate if more than one (1) application form is submitted;
- Verify the validity of the information supplied by the candidate and to reject any application form where the contents is inaccurate or incomplete;
- In it's sole and absolute discretion, cancel this public notice without award or compensation or indemnity whatsoever to the applicants;
- Reject any and all application forms;
- Request any other necessary information to evaluate the candidate. Failure for the candidate to provide the information requested may result in the candidate's reject.
