

# PUBLIC NOTICE

## FOR ADAPTED SERVICES TO TAXI PERMIT OWNERS



**Montréal, July 29th 2015** – Aéroports de Montréal (“ADM”) wishes to grant fifteen (15) Airport “Adapted-Taxi” Permits for the Montréal – Pierre Elliott Trudeau International Airport (the “Airport”) for a period of four (4) years from November 15, 2015 to November 14, 2019 and invites all taxi permit owners to submit their candidacy in accordance with the following terms and conditions.

### Conditions of eligibility (collectively the “Conditions”):

Only candidates meeting the following conditions will be eligible:

1. To be the holder of a valid regular services taxi transportation permit issued by “Commission des Transports du Québec” and assigned for the territory of the Island of Montréal and more particularly for Area A-05 : East of Montréal; Area A-11 Montréal; or Area A-12: West of Montréal.
2. To be the holder of a valid identification sticker from the “Bureau du Taxi de Montréal”.
3. Satisfy the “General Conditions” and “Particular Conditions” governing the eligibility of the candidates, issued with the registration form which is available as of August 3, 2015 through August 14, 2015, at **Aéroports de Montréal, 975, Roméo-Vachon Nord – Room 303 (3rd floor), Dorval, Québec, H4Y 1H1**, from Monday to Friday (8:00 to 4:00 PM).

The documents are available on ADM's website (<http://www.admtl.com/en/business/suppliers/taxis-limousine>), as of August 3, 2015.

4. To submit the duly completed application form, to **Aéroports de Montréal, 975, Roméo-Vachon Nord – Room 332 (3rd floor), Dorval, Québec, H4Y 1H1**, on the above mentioned opening hours, **no later than August 14, 2015**. Registration form not duly completed or received after August 14, 2015 at 4:00 PM will automatically be rejected, whatsoever the reason.

The candidate can submit only one (1) candidacy in order to obtain an Airport “Adapted Taxis” Permit (maximum of 1 permit per owner of adapted services taxi permit), under penalty of having all his applications forms, related to this draw, cancelled.

5. Applicants cannot have any outstanding account with ADM.

### Registration Costs:

Each candidate who wish to offer his candidacy following this public notice, must pay to ADM, with his inscription's deposition, registration fees of forty dollars (\$ 40.00), by credit card (MasterCard, Visa, Amex) or debit card when submitting his application form.

### Selection:

On September 2, 2015, under the supervision of an accounting firm, ADM will proceed with a draw for the issuance of the fifteen (15) Airport “Adapted Taxis” Permits for the period of November 15, 2015 to November 14, 2019.

**The results of the draw will be posted on September 3, 2015 on the ADM website ([admtl.com](http://admtl.com)) and in the Taxis and Limousines basin.**

### Reservations:

Notwithstanding any provisions to the contrary, ADM reserves the right to:

- Disqualify a candidate in the event that the candidate do not qualify under the “Particular Conditions” and “General Conditions”.
- Disqualify a candidate if more than one (1) application is submitted.
- Verify the information provided by the candidate and reject any application form where the contents is inaccurate or incomplete.
- Cancel this public notice at its sole discretion; without awarding any permit, compensation and indemnity of any kind.
- Deliver less than fifteen (15) Airports “Adapted-Taxi” Permits.
- Reject any and all applications forms.
- Request any other necessary information to evaluate the candidate. Failure for the candidate to provide the information requested may result in the candidacy being reject.
