



PUBLIC NOTICE FOR TAXI OWNERS

Aéroports de Montréal («ADM») wishes to grant a total of eight hundred and seventy (870) Airport Taxi Permits valid for one (1) year each during the next three (3) years (from February 22nd, 2006 to February 21st, 2009) for the Montréal-Pierre Elliott Trudeau International Airport (the «Airport») and invites all taxi owners to submit their candidacy, the whole in accordance with the following terms and conditions.

1) Conditions of Eligibility (collectively the « Conditions ») :

Only candidates meeting the following conditions will be eligible:

- Be the holder of a valid taxi transportation permit issued by “Commission des Transports du Québec” and assigned for the territory of the Island of Montréal and more particularly for Area A.5 : East of Montreal; Area A.11 : Montreal; and Area A.12 : West of Montreal.
- Complete application form which will be available and remitted by ADM with the “Particular Conditions” (**Particular Conditions Applicable to Airport Taxi Permits, effective February 22, 2006 to February 21, 2009**) as of Monday, January 9th, 2006 at the Control boot located in the Commercial Vehicle lot at the Airport (open Monday to Sunday from 6:30 A.M. to 01:30 A.M.).
- Duly completed application forms must be received at the ADM’s office located in the Terminal Building, room 327, no later than Wednesday, January 18th, 2006 at 3:30 P.M. Business hours are from Monday to Friday from 9:30 A.M to 11:30 A.M. and 1:30 P.M. to 3:30 P.M. No application forms will be accepted after **Wednesday, January 18th, 2006 at 3:30 P.M** for any reason whatsoever.
- must submit only one (1) application form (maximum of one (1) permit for each taxi owner) .
- must not have any outstanding account with ADM.
- must comply with and meet all other criteria of eligibility more fully described in the “Particular Conditions” as above-mentioned available with the application form.

2) Registration Costs:

Each candidate must pay to ADM registration fees of ten dollars (\$10.00), by cash or credit card only, with the application form.

3) Selection:

At the end of January 2006, a random draw sequence of 870 candidates shall be performed by ADM among the application forms duly completed and received by ADM within the prescribed time period.

Following the random draw, ADM will verify and check the group of 870 candidates' eligibility in accordance with the Conditions indicated in paragraph 1 above. Following this evaluation and verification, ADM will issue 870 taxi permits valid for one (1) year each and divided in three (3) periods, being 290 permits for the period of February 22, 2006 to February 21, 2007; 290 permits for the period of February 22, 2007 to February 21, 2008; and 290 permits for the period of February 22, 2008 to February 21, 2009, the whole without any renewal and subject to all Conditions indicated in paragraph 1.

4) Reservations:

Notwithstanding any provision to the contrary, ADM reserves the right to:

- Disqualify a candidate in the event that its application form does not contain the necessary information to permit a thorough analysis;
- Verify the validity of the information supplied by the candidate and to reject any application form where the contents is inaccurate or incomplete;
- Award less than eight hundred and seventy (870) taxi permits;
- In its sole and absolute discretion, cancel this public notice without award or compensation or indemnity whatsoever to the applicants;
- Reject any and all application forms;
- Request any other necessary information to evaluate the candidate. Failure for the candidate to provide the information requested may result in the application form being rejected.
